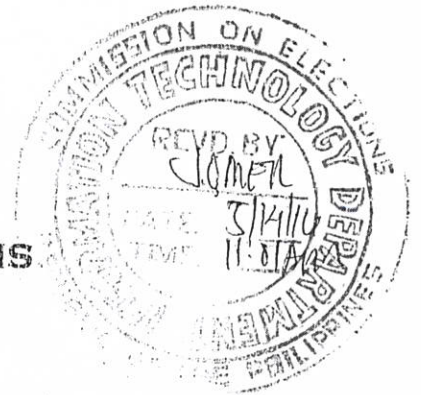


For Your Honors' consideration."




