EXECUTIVE ORDER }  
No. 23. }

Pursuant to the provisions of Act Numbered Six hundred and forty-eight, Philippine Commission, entitled "An Act authorizing the Governor-General to reserve for civil public purposes, and from sale or settlement, any part of the public domain not appropriated by law for special public purposes, until otherwise directed by law, and extending the provisions of Act Numbered Six hundred and twenty-seven so that public lands desired to be reserved by the Insular Government for public uses, or private lands desired to be purchased by the Insular Government for such uses, may be brought under the operation of the Land Registration Act," I hereby reserve for watershed purposes and withdraw from sale or settlement the following described parcel of public domain in the sitio of Kabunsud, barrio of San Diego, municipality of San Pablo, Province of Laguna, Island of Luzon, to wit:

Beginning at point marked 1 on plan, N. 69° 54' E. 7,453.0 m. from B. L. L. M. No. 1, San Pablo, thence S. 23° 44' W. 1,754.88 m. to point 2; N. 29° 45' W. 770.3 m. to point 3; N. 40° 40' W. 906.90 m. to point 4; N. 56° 55' W. 340.5 m. to point 5; N. 52° 36' W. 179.01 m. to point 6; N. 16° 20' W. 95.8 m. to point 7; N. 57° 25' W. 198.74 m. to point 8; N. 59° 05' E. 188.81 m. to point 9; S. 79° 33' E. 107.41 m. to point 10; N. 49° 41' E. 238.72 m. to point 11; N. 80° 47' E. 326.07 m. to point 12; N. 83° 25' E. 316.82 m. to point 13; S. 72° 07' E. 455.18 m. to point 14; N. 2° 41' W. 223.32 m. to point 15; N. 71° 15' E. 107.02 m. to point 16; S. 42° 45' E. 388.57 m. to point 17; S. 38° 22' E. 364.87 m. to point 18; S. 72° 29' E. 124.24 m. to point 19; S. 48° 15' E. 110.12 m. to point 1, point of beginning.

Containing 2,393,927 square meters.

Points 1, 7, 10, 11, 12, 13, and 19, rocks in place marked M. N.; points 2, 3, 4, and 5, trees marked S. P. M. N.; points 6, 8, 15, 17, and 18, trees; point 9, wood marked M. N.; point 14, crossed rock in place.

Bounded on northeast by properties of Narciso Asegurado, Esteban Esles, Bonifacio Sumagui, Eustaquio Esles, and Filomeno Esles; on southeast by public land and property of Tito Tecson; on southwest by properties of Tito Tecson, Hilario Maghirang, Francisco Capeña, Perfecto Brion, Dionisio Capinpin, Melecio Daya, Ana Aquino, Marcelino Caperiña, and Macario Capono; on northwest by properties of Macario Capono, Severo Veniza, Juan Suministrado, Esteban Esconde, Praxedes Maghirang, Ciriaco Ortega, Lorenzo Oroquia, Severino Llorena, Filomeno Plenilunio, Agripino Sumagui, and Juan Esles.

Lot "A," 4,424 square meters, included within boundary lines of above-described property, is claimed by the municipal government of San Pablo, Laguna, as follows: Beginning at point marked 1 on plan, N. 62° 15' E. 5,596.75 m. from B. L. L. M. No. 1, San Pablo, thence S. 79° 52' E. 37.04 m. to point 2; S. 23° 29' E. 112.75 m. to point 3; N. 52° 36' W. 132.76 m. to point 4; N. 11° 56' W. 11.44 m. to point 5; N. 55° 37' E. 32.05 m. to point 1, point of beginning.
