PROCLAMATION NO. 67

CALLING THE CONGRESS OF THE PHILIPPINES TO A SPECIAL SESSION.

WHEREAS, the public interest requires that the Congress of the Philippines be convened in a special session in order to consider urgent legislative measures;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by the Constitution, do hereby call the Congress of the Philippines to a special session for such number of days as may be necessary but not to exceed thirty (30) days commencing on August 15, 1966, at ten o'clock in the morning, to consider the following subjects and such other subjects as may be certified to the Congress by me:
