PROCLAMATION NO. 228

RESERVING FOR PLAYGROUND SITE PURPOSES A CERTAIN PARCEL OF
LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY
OF CARDONA, PROVINCE OF RIZAL.

Upon the recommendation of the Secretary of Agriculture
and Natural Resources and pursuant to the authority vested
in me by law, I, FERDINAND E. MARCOS, President of the
Philippines, do hereby withdraw from sale or settlement and
reserve for playground site purposes under the administration
of the Municipal Government of Cardona, Province of Rizal,
subject to private rights, if any there be, a certain parcel
of land of the public domain situated in the said municipality
more particularly described as follows:

Lot 1

Psu-229632

The Municipal Government of Cardona

A parcel of land (Lot 1 of plan Psu-229632,
L.R.C. Record No.), situated in the Barrio
of Dalag, Municipality of Cardona, Province of
Rizal. Bounded on the NW., along line 1-2 by
property of Reynaldo Concepcion; on the N., along
line 2-3 by Laguna Bay; on the SE., along lines
3-4-5 by barrio outlet canal; and on the S., along
line 5-6 by property of Juan Hibbing; on the W.,
S. and E., along lines 6-7-8-9- by Lot 2 of plan
Psu-229632; on the S., along line 9-1 by property
of Aurelio Constantino. Beginning at a point
marked "1" on plan, being S. 56 deg. 17' E., 468.23
m. from B.L.L.M. 3, Mpty. of Cardona, Rizal;

thence N. 11 deg. 53' E., 53.77 m. to point 2;
thence S. 80 deg. 06' E., 28.13 m. to point 3;
thence S. 9 deg. 55' W., 37.48 m. to point 4;
thence S. 14 deg. 40' W., 21.17 m. to point 5;
thence N. 79 deg. 48' W., 11.52 m. to point 6;
thence N. 12 deg. 01' E., 21.47 m. to point 7;
thence N. 89 deg. 29' W., 10.01 m. to point 8;

thence S. 9 deg. 05' W., 16.54 m. to point 9;
thence N. 69 deg. 21' W., 7.99 m. to the point

of beginning; containing an area of ONE THOUSAND
FOUR HUNDRED SIXTY TWO (1,462) SQUARE METERS. All
points referred to are indicated on the plan and
are marked on the ground by P.S. Cyl. Conc. Mons.;
bearings true; date of the survey, May 9, 1966 and
that of the approval, February 20, 1967.
