PROCLAMATION NO. 158

ESTABLISHING AS HAPOL-AGAN FOREST RESERVE, THE PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF MANGKAYAN, PROVINCE OF BENGUET, ISLAND OF LUZON, PHILIPPINES

UPON THE RECOMMENDATION OF THE SECRETARY OF ENVIRONMENT AND NATURAL RESOURCES, AND PURSUANT TO THE POWERS VESTED IN ME BY LAW, I, CORAZON C. AQUINO, PRESIDENT OF THE PHILIPPINES, DO HEREBY SET ASIDE AS HAPOL-AGAN FOREST RESERVE FOR PROTECTION FOREST AND GREENBELT PURPOSES, SUBJECT TO EXISTING VALID RIGHTS, IF ANY THERE BE, A PARCEL OF LAND OF THE PUBLIC DOMAIN LOCATED IN BARRIO SAPID, MUNICIPALITY OF MANGKAYAN, PROVINCE OF BENGUET AS SHOWN IN THE BUREAU OF FOREST DEVELOPMENT MAP F.R.-174, WITH THE FOLLOWING DESCRIPTION:

BEGINNING AT A POINT MARKED "1" ON THE PLAN, IDENTICAL TO CORNER 5 OF LCMC TIMBER CONCESSION:

THENCE S $78^{\circ}14'$ E, 176.83 METERS TO CORNER 31, TRIANGULATION POINT, ON TOP OF TAGPAYA RIDGE;

THENCE N $47^{\circ}38'$ E, 230 METERS TO CORNER 32, STAKE, ON RIDGE;

THENCE N $47^{\circ}38'$ E, 200 METERS TO CORNER 33, STAKE, ON RIDGE;

THENCE N $47^{\circ}38'$ E, 172.79 METERS TO CORNER 34, PINE TREE, 80 CM. IN DIAMETER, ON TOP OF TAGPAYA RIDGE;

THENCE N $36^{\circ}06'$ E, 150 METERS TO CORNER 35, STAKE,
ON RIDGE;

THENCE N $36^{\circ}06'$ E, 169.17 METERS TO CORNER 36, ROCK,
MARKED X, ON TOP OF HAPOL-AGAN CREEK;

THENCE S $50^{\circ}05'$ E, 200 METERS TO CORNER 37, STAKE,
ON EAST SIDE OF ROAD;

THENCE S $50^{\circ}05'$ E, 180 METERS TO CORNER 38, STAKE,
ON GRASS LAND;

THENCE S $50^{\circ}05'$ E, 240 METERS TO CORNER 39, STAKE,
ON GRASS LAND;

THENCE S $50^{\circ}05'$ E, 102.90 METERS TO CORNER 1, THE
POINT OF BEGINNING, CONTAINING AN AREA OF TWO HUNDRED
NINETY FIVE (295) HECTARES, MORE OR LESS.

THE RESERVATION SHALL BE UNDER THE ADMINISTRATIVE JURISDICTION,
SUPERVISION, CONTROL AND MANAGEMENT OF THE DEPARTMENT OF ENVIRON-
MENT AND NATURAL RESOURCES THROUGH ITS APPROPRIATE AGENCY.

IN WITNESS WHEREOF, I HAVE HEREUNTO SET MY HAND AND CAUSED
THE SEAL OF THE REPUBLIC OF THE PHILIPPINES TO BE AFFIXED.
