PROCLAMATION NO. 886

RESERVING FOR BILLET-STEELMAKING PLANT SITE PURPOSES OF THE NATIONAL STEEL CORPORATION A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE BARANGAY OF FUENTES, CITY OF ILIGAN, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from sale or settlement and reserve for Billet Steelmaking Plant site purposes, under the administration of the National Steel Corporation in coordination with the Department of Environment and Natural Resources with the objective of maintaining the usefulness of the land, subject to private rights, if any there be, a certain parcel of land of the public domain situated in the Barangay of Fuentes, City of Iligan, Island of Mindanao, which parcel is more particularly described as follows, to wit:

A PARCEL OF LAND, Lot No. 6460-A, Csd-12-003685-D, a portion of Lot No. 6460, Cad-292, equivalent to Lot No. 6745, Iligan Cadastre, Cad-292, situated in the Barangay of Fuentes, City of Iligan, Island of Mindanao. Bounded on the SW., along line 1-2 by Lot No. 6460-B, Csd-12-003685-D; on the W., along line 2-3 by Lot No. 28, Ir-1028, parcel 4 (Iligan Bay); on the NE., along lines 3-4-5-6-7 by Nonucan river; on the SE., along line 7-8 by Lot No. 2043 (portion), Cad-292, Iligan Cadastre (portion of Lot 14, Ir-1028); and long lines 8-9-1 by National Highway. Beginning at a point marked "1" of Lot 6460-A, Csd-12-003685 being S. 54° 30' W., 4,574.74 m. from BLLM No. 1, Cad-292, Iligan Cadastre. Thence
