PROCLAMATION NO. 906

RESERVING FOR RESETTLEMENT SITE PURPOSES OF THE MOUNT PINATUBO VICTIMS A CERTAIN PORTION OF THE OLONGAPO WATERSHED FOREST RESERVE LOCATED IN NEW CABALAN, CITY OF OLONGAPO, ISLAND OF LUZON

In consideration of the urgent need to assist the families affected by the eruption of Mt. Pinatubo by providing them with suitable resettlement areas and livelihood opportunities conducive to their economic recovery, and upon recommendation of the Secretary of Environment and Natural Resources and the Presidential Task Force created under Memorandum Order No. 369, dated June 26, 1991, and by the powers vested in me by law, I CORAZON C. AQUINO, President of the Philippines, do hereby reserve for resettlement and livelihood purposes, subject to private rights, if any there be, and to future classification and survey, a parcel of land segregated from the Olongapo Watershed Reservation (F.R. No. 132), situated in the City of Olongapo, Island of Luzon, and more particularly described as follows:

A PARCEL OF LAND (Being a portion of the Olongapo Watershed Reservation F.R. No. 132, as shown in the attached plan) situated in Sitio Iram, Barangay New Cabalan, City of Olongapo, Island of Luzon. Bounded on the NW., along line 1-2 by Block II, Project 14-A, LC-3357; on the N., along lines 2-11 by Irang Creek ; on the E., along lines 11-20 by the Established Plantation of the Iram Forest Nursery, Olongapo Reforestation Project; on the S., along lines 20-34 by Banga River; on the SW. and NW. along lines 34-1 by Block II Project 14-A, LC-3557. Beginning at a point marked "1" on plan SWO-03-000184, being N. 56 deg. 17'E., 6138.74 m. from BLLM No. 1. Olongapo Townsite Reservation, TS-308. Thence . . .


of beginning, containing an area of ONE MILLION (1,000,000) SQUARE METERS, MORE OR LESS.

The lots within this Proclamation shall be disposed of through stewardship contract under the Integrated Social Forestry Program inasmuch as the area is presently classified as forest land subject to appropriate modes of disposition under the Public Land Law, as amended, should there be a reclassification later.


