PROCLAMATION NO. 178
ESTABLISHING AS LUCNAB WATEERSHIGD FORESY RESERVE FOR
PURPOSES OF PROTECTING, MAINTAINING, OR IMPROVING ITS
WATER YIELD AND PROVIDING RESTRAINING MECHANISM FOR
INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-
USE, CERTAIN PARCELS OF LAND OF THE PUBLIC DOHAIN
SITUATED IN RESIDENCE SECTION "D", CITY OF BAGUIO, ISLAND
OF LUZON, PHILIPPINES.

Upon recommendation of the secretary of the Department of Environment and Natural Resources, by virtue of the powers vested in me by law and pursuant to Section 18, P.D. No. 705, otherwise known as the Forest Reform Code of 1975, I, FIDEL V. RAMOS, President of the Republic of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Lucnab Watershed Forest Reserve under the administrative jurisdiction, supervision and control of the Department of Environment and Natural Resources in coordination with other agencies of the government with the objective of maintaining its usefulness as a source of water for domestic use and other forestry purposes subject to private rights, if any there be, certain parcels of land of the public domain situated in Residence "D", City of Baguio, Island of Luzon, and more particularly described as follows:

Lot 1, Swo-CAR-042
