PROCLAMATION NO. 395

ESTABLISHING AS BULAWAN FALLS WATERSHED FOREST RESERVE FOR PURPOSES OF PROTECTING, MAINTAINING, OR IMPROVING ITS WATER YIELD AND PROVIDING RESTRAINING MECHANISM FOR INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LANDUSE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF DINALUNGAN, PROVINCE OF AURORA, ISLAND OF LUZON, PHILIPPINES

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from entry, sale, disposition, or settlement and set aside as Bulawan Falls Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamation reserving any portion thereof for specific purposes and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of Environment and Natural Resources, a certain parcel of land of the public domain located in the Municipality of Dinalungan, Province of Aurora, as shown in the Forest Management Bureau Map No. 115 with the following descriptions:

Beginning at point "l" on the map, Balakat 20 cm. identical to corner No. 70 of Project 12-1, Timberland, Province of Aurora;

Thence S 82 00'W, 300 meters to corner 2, Tobog, 30 cm identical to corner no. 71 of Project 12-1. Timberland;

Thence N 72 00'W, 200 meters to corner 3, White Lauan, 30 cm. identical to corner no. 72 of Project 12-1, Timberland;

Thence S 76 00'W, 240 meters to corner 4, White Lauan, 30 cm. identical to corner no. 73 of Project 12-1, Timberland;

Thence N 47 00'W, 800 meters to corner 5, a point on the ground;

Thence N 11 10'E, 1,152.6 meters to corner 6, a point on the ground;



Thence N 08 50'W, 851 meters to corner 7, a point on the ground;

Thence N 24 34'W, 748.7 meters to corner 8, a point on the ground;

Thence N 18 39'W, 949.6 meters to corner 9, a point on ground;

Thence N 05 53'E, 1001.5 meters to corner 10, a point on the ground identical to corner 21 of Talaytay Watershed;

Thence S 37 00'E, 500 meters to corner 11, a point on ground, identical to corner 11 of Calabgan Watershed;

Thence S 54 00'E, 990 meters to corner 12, a point on the ground, identical to corner 10 of Calabgan Watershed;

Thence S 69 00'E, 990 meters to corner 13, a point on the ground, identical to corner 9 of Calabgan Watershed;

Thence S 64 00'E, 675 meters to corner 14, a point on the ground, identical to corner 8 of Calabgan Watershed;

Thence S 86 00'E, 600 meters to corner 15, a point on the ground;

Thence S 02 00'W, 2,080 meters to corner 16, a point on the ground;

Thence S 45 00'W, 440 meters to corner 17, White Lauan, 25 cm. identical to corner 63, Project 12-1, Timberland;

Thence S 49 00'W, 260 meters to corner 18, Guijo, 60 cm. identical to corner no. 64 of Project 12-1, Timberland;

Thence S 45 00'W, 110 meters to corner 19, Kalantas, identical to corner no. 65 of Project no. 12-1, Timberland;

Thence S 76 00'W, 320 meters to corner 20, White Lauan, 60 cm. identical to corner no. 66 of Project 12-1, Timberland;

Thence S 59 00'W, 220 meters to corner 21, Guijo, 40 cm. identical to corner no. 67 of Project 12-1, Timberland;

Thence S 21 00'W, 230 meters to corner 22, White Lauan, 25 cm. identical to corner no. 68 Project 12-1, Timberland;

Thence S 38 00'W, 200 meters to corner 23, White Lauan, 25 cm. identical to corner no. 69 Project 12-1, Timberland;

S 38 00'W, 200 meters to corner "1" a point of beginning containing an area of NINE HUNDRED EIGHTY (986) HECTARES more or less.

The area covered by the reservation shall be under administrative jurisdiction, supervision, and control of the Department of Environment and Natural Resources, thru its Management Bureau, in coordination with agencies of the government with the objective of maintaining usefulness as a source of water for agricultural, and other purposes.
