## PROCLAMATION NO. 733

RESERVING AS SCHOOL SITE A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF BANSALAN, PROVINCE OF DAVAO DEL SUR, ISLAND OF MINDANAO

Upon recommendation of the Secretary of the Department of Environment and Natural Resources and by virtue of the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from sale, entry, disposition or settlement and reserve for school site purposes, under the administration of the Department of Education, Culture and Sports, subject to private rights if there be any, a certain parcel of land of the public domain situated in the Municipality of Bansalan, province of Davao del Sur, Island of Mindanao, which is more particularly described as follows:
