PROCLAMATION NO. 850

CREATING AND DESIGNATING CERTAIN LANDS OF THE PRIVATE DOMAIN SITUATED IN BARANGAY CALIBUTBUT, MUNICIPALITY OF BACOLOR, PROVINCE OF PAMPANGA, AS A SPECIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916

Pursuant to the powers vested in me and under Republic Act No. 7916, the Special Economic Zone Act of 1995, I, FIDEL V. RAMOS, President of the Philippines, do hereby create and designate, subject to the provisions of Republic Act No. 7916, its Implementing Rules and Regulations, and Resolution Nos. 95-161, dated December 6, 1995, 96-188 dated May 22, 1996, and 96-189 dated June 6, 1996 of the Board of Directors of the Philippine Economic Zone Authority, an area located in Barangay Calibutbut, Bacolor, Province of Pampanga, as the ANGELES INDUSTRIAL PARK - ECOZONE consisting of Thirty Two (32) hectares, more or less, as defined by the following technical description:

A parcel of land (Lot 34, of the subd., plan Psd-03-021 394, being a portion of Lot 3020, Cad. 73 Bacolor Cad., LRC. Rec. No.), situated in the Bo. of Calibutbut, Mun. of Bacolor, Prov. of Pampanga. Bounded on the SE., along line 1-2 by Rd. Lot 37, on the SW., along line 2-3-4 by lot 3014, Cad. 73 Bacolor Cad.; along line 4-5-6 by lot 3021 Cad. 73 Bacolor Cad.; on the NE., along line 6-7-8 by Bo. Rd. on the SE., along line 8-9 by Rd. Lot 30; on the SW., along line 9-10 by Lot 32, of the subd., plan; on the N., along line 10-11 by Lot 32, along line 11-12 by Lot 30, along line 12-13 by Lot 28; along line 13-14 by Lot 36; along line 14-15 by Lot 24, all of the subd., plan; on the SW., along line 15-16 by Rd.
