PROCLAMATION NO. 1043

RESERVING FOR THE GOVERNMENT SITE PURPOSES OF THE CITY GOVERNMENT OF COTABATO CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN SITUATED AT POBLACION, CITY OF COTABATO, ISLAND OF MINDANAO

Upon recommendation of the Secretary of the Department of Environment and Natural Resources and by virtue of the powers vested in me by law, **I**, **FIDEL V. RAMOS**, President of the Philippines, do hereby withdraw from sale, settlement and reserve for government site purposes of the City of Government of Cotabato, certain parcels of land of the public domain situated at Poblacion, City of Cotabato, Island of Mindanao, subject to private rights if any there be, which parcels are more particularly described as follows:
