## BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO. 1218
EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 208 DATED MAY 28, 1967 WHICH RESERVED AN AREA FOR NATIONAL SHRINE PURPOSES SITUATED IN TAGUIG, RIZAL NOW (METROPOLITAN MANILA), CERTAIN PORTIONS OF THE LAND EMBRACED THEREIN AND DECLARING THE SAME AS THE ARMED FORCES OF THE PHILIPPINES RETIREMENT AND SEPARATION BENEFITS SYSTEM (AFP-RSBS) INDUSTRIAL PARK

Upon recommendation of the Secretary of Environement and Natural Resources and by virtue of the powers vested in me by law, I, FIDEL V. RAMOS, President of the Republic of the Philippines, do hereby exclude from the operation of Proc. 208 dated May 28, 1967, which reserved an area for National Shrine purposes situated in the Municipality of Taguig, Metro Manila, certain portions of the land embraced therein and declaring the same as the Armed Forces of the Philippines-Retirement and Separation Benefits System (AFPRSBS) Industrial Park under the administration of the AFP Chief of Staff, subject to private rights if there be any, which portions are more particularly described as follows:

LOT 1

Bounded on the NE, along lines 1-2 by Lot 3 ; on the SE., and SW., along line 2-3-4-5 by Lot 1 ; and on the NW., along lines 5-6-7-1 by Lot 6, all of the consolidation subdivision plan, Swo-00-001302 (NOTE: Lot 2, Swo-00-001302 is a portion of Lot 4, Swo-13-000298). A PARCEL OF LAND (Lot 3 of the consolidated subdivision plan Swo-00-001302, being a portion of the consolidations of Lot 3 and 4 Swo-13-000298, and parcel 3, Psu2031), situated in Barangay Western Bicutan, Municipality of Taguig, Metro Manila, Island of Luzon. Bounded on the NW., along lines $1-2$ by Lot 4 ; on the NE., along line $2-3$ by Lot 10; on the SE., along line 3-4 by Lot 12; and along lines 4-5-6-7-8 by Lot 1; and on the SW., along line 8-1 by Lot 2, all of the consolidation subdivision plan, Swo-00-001302. (NOTE: Lot 2, Swo-00-001302 is a portion of Lot 4, Swo-00000298).
