PROCLAMATION NO. 2047

CREATING AND DESIGNATING TWO PARCELS OF LAND, TO BE KNOWN AS EMBARCADERO DE LEGAZPI, LOCATED AT LEGAZPI PORT AREA, LEGAZPI CITY, PROVINCE OF ALBAY, AS TOURISM WITH INFORMATION **TECHNOLOGY** ECONOMIC ZONE COMPONENT PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748
