PROCLAMATION NO. 2050

RESERVING A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN IN BARANGAY AUMBAY, SAMAL DISTRICT, ISLAND GARDEN CITY OF SAMAL, PROVINCE OF DAVAO DEL NORTE, ISLAND OF MINDANAO AS SCHOOL SITE PURPOSES FOR AUMBAY ELEMENTARY SCHOOL AND GRANTING OWNERSHIP THEREOF IN FAVOR OF THE REPUBLIC OF THE PHILIPPINES-DEPARTMENT OF EDUCATION (RP-DEPED)

Upon the recommendation of the Secretary of the Department of Environment and Natural Resources (DENR) and by virtue of the powers vested in me by law, **I**, **GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby withdraw from sale, lease or settlement and reserve a certain parcel of land of the public domain as school site purposes for **Aumbay Elementary School**, and granting ownership thereof in favor of the Republic of the Philippines-Department of Education (RP-DepEd), subject to private rights, if any there be, situated in Barangay Aumbay, Samal District, Island Garden City of Samal, Province of Davao del Norte, Island of Mindanao, which parcel of land is more particularly described as follows:

"Lot 1646-A, Csd-11-010183-D Portion of Lot 1646, Pls-532-D

A PARCEL OF LAND identified as Lot 1646-A, Csd-11-010183-D, portion of Lot 1646, Pls-532-D, situated in Barangay Aumbay, Samal District Island Garden City of Samal, Province of Davao del Norte, Island of Mindanao.

Bounded on the NE., along line 1-2 by Lot 1576, Pls-532-D; on the SE., along line 2-3, on the SW., along line 3-4, on the NW., along line 4-1, all of lot 1646-B, Csd-11-010183-D.
