

Please take notice that the Court, First Division, issued a Resolution dated July 20, 2015 which reads as follows:

"G.R. No. 213916 (People of the Philippines v. Bencent Maturan y Molig). — After a judicious perusal of the records, the Court resolves to **DISMISS** the appeal for failure to sufficiently show that the Court of Appeals (CA) committed any reversible error in its assailed Decision as to warrant the exercise of the Court's appellate jurisdiction.

WHEREFORE, the Court ADOPTS the findings of fact and conclusions of law in the November 29, 2013 Decision¹ of the CA in CA-G.R. CEB-CR HC No. 01511 and AFFIRMS said Decision finding accused-appellant Bencent Maturan y Molig GUILTY beyond reasonable doubt of Illegal Sale of Dangerous Drugs in violation of Section 5, Article II of Republic Act No. 9165,² otherwise known as the "Comprehensive Dangerous Drugs Act of 2002," sentencing him to suffer the penalty of life imprisonment, and to pay a fine of ₱500,000.00.
