

Please take notice that the Court, First Division, issued a Resolution

dated January 26, 2015 which reads as follows:

[°]G.R. No. 214387 (Catalino A. Soto v. People of the Philippines and Rezolito Paño^{*}).- The petitioner's motion for an extension of thirty (30) days within which to file a petition for review on certiorari is GRANTED, counted from the expiration of the reglementary period.

After a judicious perusal of the records, the Court resolves to **DENY** the instant petition and **AFFIRM** the October 8, 2013 Decision¹ and September 18, 2014 Resolution² of the Court of Appeals (CA) in CA-G.R. CR No. 34048 for failure of Catalino A. Soto (petitioner) to show that the CA committed any reversible error in finding him guilty of reckless imprudence punished under Article 365 of the Revised Penal Code.

The question of whose negligence (whether that of petitioner or Ejercito A. Olaguera) caused the collision which injured the victim, respondent Rezolito Paño, is basically a question of fact which, as a general rule, is beyond the scope of a petition for review on *certiorari* under Rule 45 of the Rules of Court,³ subject to certain exceptions, which do not obtain in the instant case.⁴
