

Sirs/Mesdames:

Please take notice that the Court, Second Division, issued a Resolution dated **08 July 2015** which reads as follows:

"G.R. No. 217843 – Celestino L. Bastismo v. People of the Philippines

After a careful review of the records of the case, the Court finds no reversible error in the assailed June 27, 2014 Decision of the Court of Appeals. The prosecution firmly established that petitioner Celestino L. Bastismo is guilty beyond reasonable doubt of reckless imprudence by hitting the motorcycle in front of the passenger bus he was driving, which resulted in the death of its driver Hope Segindio and passenger Genalyn Deliarte, and serious physical injuries to the other passenger, Rosalyn Deliarte. Had the hitting of the victim's vehicle been intentional, the act would constitute a grave felony.

However, the penalty imposed on petitioner must be modified to conform to Article 365 of the Revised Penal Code, which provides that the penalty of arresto mayor in its maximum period to prision correccional in its medium period shall be imposed on any person who, by reckless imprudence, shall commit any act which, had it been intentional, would constitute a grave felony. With neither aggravating nor mitigating circumstances and applying the Indeterminate Sentence Law, the indeterminate penalty must be within the range of one (1) month and (1) day to four (4) months of arresto mayor, as minimum, to one (1) year, seven (7) months and eleven (11) days to two (2) years, ten (10) months and twenty (20) days of prision correccional, as maximum.

WHEREFORE, the Court ADOPTS the findings of fact and conclusions of law in the Decision dated June 27, 2014 of the Court of Appeals in CA-GR. CR-No. 00715, and AFFIRMS said Decision with the MODIFICATION that petitioner Celestino L. Bastismo is sentenced to suffer the indeterminate prison term of four (4) months of arresto mayor, as minimum, to two (2) years, ten (10) months and twenty (20) days of prision correccional, as maximum.
