*Please take notice that the Court, First Division, issued a Resolution dated **January 29, 2020** which reads as follows:*

**“G.R. No. 230364 – JUAN A. TUBO, petitioner, versus BANK OF THE PHILIPPINE ISLANDS and ROGELIO O. LUY, respondents.**

After reviewing the instant Petition and its annexes, inclusive of the Court of Appeals’ (CA) assailed Decision<sup>1</sup> dated August 11, 2016 and assailed Resolution<sup>2</sup> dated January 25, 2017, the Court finds that petitioner Juan A. Tubo failed to present any cogent and convincing argument warranting the reversal of the CA’s assailed Decision and Resolution. There is no reversible error committed by the court *a quo* that warrants the Court’s discretionary exercise of its appellate jurisdiction.

Therefore, the Court denies the instant Petition for lack of merit.
