
*Please take notice that the Court, Second Division, issued a Resolution dated **15 March 2021** which reads as follows:*

“A.C. No. 10844 (*Paciano V. Delizo, Jr. and Hyacinth M. Delizo-Manabat v. Atty. Abraham Johnny G. Asuncion*). – The Court **NOTES the Notice of Resolution¹ dated September 7, 2019 of the Integrated Bar of the Philippines (*IBP*) Board of Governors (*Board*) which resolved to adopt and approve with modification the Report and Recommendation,² dated October 12, 2017 of the Investigating Commissioner to reprimand Atty. Abraham Johnny G. Asuncion, with a stern warning that commission of a similar offense shall be dealt with more severely; transmitted by letter dated October 8, 2020 of IBP Director Randall C. Tabayoyong, Commission on Bar Discipline, together with the records of the case.**

WHEREFORE, the Court **ADOPTS** and **APPROVES** the September 7, 2019 Resolution of the IBP Board in CBD Case No. 16-5090. Atty. Abraham Johnny G. Asuncion is found to have violated the Lawyer’s Oath as well as the Code of Professional Responsibility and is hereby **REPRIMANDED** with a **STERN WARNING** that a repetition of the same or similar act shall be dealt with more severely.
