## NOTICE

Sirs/Mesdames:

Please take notice that the Court, Second Division, issued a Resolution dated 01 February 2021 which reads as follows:

"G.R. No. 253386 (Philippine Transmarine Carriers, Inc. and/or Marin Shipmanagement Limited v. Aramis M. Orsolino). — This is a Petition for Review on Certiorari¹ under Rule 45 assailing the Court of Appeals' (CA) Decision² dated January 28, 2020 and Resolution dated August 27, 2020 in CA-G.R. SP No. 155542 which affirmed the Panel of Voluntary Arbitrators' (PVA) award of total and permanent disability benefits to a seafarer.

Considering the allegations, issues, and arguments adduced in the petition for review on *certiorari*, the Court finds no cogent reason to deviate from the CA and the PVA's findings that respondent Aramis M. Orsolino's (respondent) illness is work-related and compensable. However, the interest rate on the monetary awards must be reduced from twelve percent (12%) to six percent (6%) *per annum* consistent with prevailing jurisprudence.<sup>3</sup>

FOR THESE REASONS, the petition is **DENIED**. The Court of Appeals' Decision dated January 28, 2020 and Resolution dated August 27, 2020 in CA-G.R. SP No. 155542 are **AFFIRMED** with **MODIFICATION** in that the interest rate on the awards of disability benefits and attorney's fees is **REDUCED** from twelve percent (12%) to six percent (6%) *per annum*.
